## Initial Information

Dear Contestants,

We would like to inform you via this Policy how the companies of Moonlight Production, spol. s r. o., having its registered office at Biskupský dvůr 2095/8, Nové Město, 110 00 Prague 1, Company ID No.: 039 24 068, entered in the Commercial Register maintained by the Municipal Court in Prague under File Reference C 239973, and Bon Art Music Group spol. s r.o., having its registered office at Na výsluní 201/13, Strašnice, 100 00 Prague 10, Company ID No.: 04898656, file No.: C 255338 registered with the Municipal Court in Prague (hereinafter referred to as the "**Companies**") collect, process, use and transfer your personal data.

Personal data means information relating to a person who can be identified on the basis of that information, possibly in conjunction with other information.

The most common examples of personal data processed by the Companies in the course of their daily business activities are the identification data of competitors (minors) and their legal representatives, contact data (in particular, residence, e-mail address and telephone number) and photographs.

### I. Who is the Controller of your Personal Data

The Data Controller is the company Moonlight Production, spol. s r. o., having its registered office at Biskupský dvůr 2095/8, Nové Město, 110 00 Prague 1, Company ID No.: 039 24 068, entered in the Commercial Register maintained by the Municipal Court in Prague under File Reference C 239973 (hereinafter "**Moonlight Production**").

Moonlight Production determines how and for what purpose your personal data will be processed. Contact details for Moonlight Production can be found below in the Article "*Questions and Contacts*".

### II. What and for what Purpose the Companies Process your Personal Data

Companies process the following personal data about you:

1. Basic identification and contact details, namely
  - i. Contestant's name and surname
  - ii. Date of birth
  - iii. Residential address
  - iv. E-mail address
  - v. Phone number
  - vi. Photograph
  - vii. Video recording and audio recording

The Companies process your personal data for the purpose of negotiating and executing the relevant contracts, fulfilling the Company's legal obligations, implementing and conducting the

Contest, promoting, supporting and improving the Company's services, sending you up-to-date information and commercial messages from the Companies.

The legal basis for the processing of this personal data is (i) the conclusion and performance of the relevant Agreement or (ii) the provision of your consent to the processing of this personal data.

The Companies process such personal data of yours for the purpose of (i) cooperation under the BON ART JUNIOR FEST project (ii) publishing promotional materials related to the BON ART JUNIOR FEST (CD, DVD, printed leaflets, billboards) (iii) promotion of the BON ART JUNIOR FEST on the website [www.bonartfest.cz](http://www.bonartfest.cz) and social networks administered by the Controller (iv) promoting and improving the Controller's services (v) sending up-to-date information and commercial communications from the Controller (vi) providing personal data to third parties for the purposes of ensuring the proper functioning of the BON ART JUNIOR FEST project (e.g. producers, sound engineers, lighting technicians, etc.) (vii) negotiating and executing relevant contracts in the execution and management of the Contest.

### **III. Where Companies Obtain your Personal Data**

Companies obtain your personal data, which they then process directly from you, from their own activities based on your consent (e.g. taking a photograph) or from publicly available sources.

### **IV. Do the Companies Share your Personal Data with Others?**

Companies may share your personal information with the following people:

1. External service providers.

In particular, these entities provide accounting, legal advice, marketing and promotion, IT to the Companies and certain of your personal data must be transferred to them by the Companies in order to perform their duties.

2. Bon Art Music Group spol. s r.o., having its registered office at Na výsluní 201/13, Strašnice, 100 00 Prague 10, Company ID No.: 04898656, file No.: C 255338 kept by the Municipal Court in Prague.
3. Third parties.

Companies are required to share your personal information with third parties outside of the above entities in certain circumstances, in accordance with data protection laws. Such third parties include in particular public authorities (e.g. law enforcement authorities, tax authorities) and certain financial institutions (e.g. banks).

### **V. Do the Companies Transfer Your Personal Data to Countries Outside the EEA**

Companies do not transfer your personal data outside the European Economic Area.

### **VI. How your Personal Data is Secured**

Companies use modern IT security systems to ensure the confidentiality, integrity and availability of your personal data. Companies maintain appropriate technical and organisational security

measures against unlawful or unauthorised processing of personal data and against accidental loss or damage to personal data.

Access to your personal data is only granted to persons who need it to perform their work duties and are bound by a legal or contractual obligation of confidentiality.

## **VII. How long the Companies will Retain your Personal Data**

The Companies will retain your personal data only for as long as they need it for the purpose for which it was collected, or to protect the legitimate interests of the Companies, or for as long as you have consented to its processing.

If the Companies process the data on the basis of your consent, they will do so for a period of ten (10) years after the consent is given, or until the consent is withdrawn.

## **VIII. What are Your Rights Regarding the Processing of Personal Data**

Under the conditions set out below, you may exercise all the rights granted to you under the data protection legislation, in particular the General Data Protection Regulation (GDPR):

- i. the right to clear, transparent and comprehensible information about how your personal data is used and what your rights are;
- ii. the right to withdraw your consent to the processing of personal data at any time, free of charge, by post, email or in person at our address below;
- iii. the right to access to personal data and to be provided with other information related to its processing by the Companies or their processors;
- iv. the right to rectification of incorrect and incomplete personal data;
- v. the right to erasure of personal data, in particular if (i) they are no longer necessary for further processing; (ii) consent to their processing has been withdrawn; (iii) the data subject has legitimately objected to their processing; (iv) they have been unlawfully processed; or (v) they must be erased pursuant to law;
- vi. the right to restrict the processing of personal data where (i) the data subject has contested the accuracy of the personal data for a period of time until the Companies verify its accuracy; (ii) the processing is unlawful; (iii) the Companies no longer need the personal data but the data subject needs the personal data for the purposes of asserting his or her legal claims; or (iv) the data subject objects to the processing of the personal data for a period of time until the Companies verify whether the legitimate interests of the Companies outweigh the interests of the data subject;
- vii. the right to object to the processing of personal data if it is processed for the purposes of the Companies' legitimate interests.
- viii. the right to obtain your personal data and to transfer it to another controller, subject to compliance with the legal conditions;
- ix. the right to lodge a complaint with the Office for Personal Data Protection, Pplk. Sochora 27, 170 00 Prague 7; [www.uoou.cz](http://www.uoou.cz) if you believe that the Companies are in breach of their obligations under data protection legislation.

We will respond to your requests to exercise your rights within the statutory time limit, usually no later than one (1) month from receipt of the request. Should our response take longer in exceptional cases, we will inform you.
