  - 9) 9. – 13 October 2026 – All Competitors will be together on this date – Prague
  - 10) 13 October 2026 – Final Gala Evening – Prague – Hybernia Theatre
  
2. **Reservation of the Schedule Changes Right.** *The Competition Promoter reserves the right to make any and all changes to the dates and locations of all activities listed in the Schedule, as well as any other changes deemed appropriate and necessary for the proper participation of the Competitor in the Competition in accordance with the Competition Terms and Conditions.*
